General Information

What is IYC (International Youth Convention)?

In the late 1990s, the youth ministry team developed an overall purpose statement for IYC: to create a moment for life change. This primary purpose drives everything that happens at convention.

Because of IYC, thousands of young men and women have made life-changing decisions.

In the last three conventions alone, thousands of teenagers have pledged to remain sexually pure. Thousands of youth have gone to the prayer room to get straight with God. Hundreds of teenagers have indicated a sense of a call to full time ministry or missions.

The Farmington Hills Church of God Youth Ministry has participated in IYC for many years. We've been to Cincinnati in 1998, Orlando in 2000, Denver in 2002, Nashville in 2004, Anaheim in 2006, San Antonio in 2008, and Orlando in 2010.

Payment Schedule

- **Wednesday, January 11, 2012** is the Sign-Up Commitment Date. Please complete the Commitment form, the IYC Impact Denver Release form, and return them by this date with your \$300 payment.
- **Sunday, March 11, 2012** is the 2nd Payment due date. Payment of \$250 is due.
Note: This will be the date of an IYC Meeting for Youth & Parents.
- **Wednesday, May 9, 2012** is the 3rd Payment due date. Payment of \$300 is due.
- **Sunday, June 3, 2012** is the Final Payment due date. Final Payment of \$250 is due.
Note: This will be the date of the final IYC Meeting for Youth & Parents.

General Information

How will I find out my payment status?

- To ensure that payments remain up to date and to provide information about IYC 2012 Fundraisers, each parent will be sent a payment status approximately 2 weeks before a payment is due (starting in March 2012). **Please be sure to provide your e-mail address and/or address on the commitment form. - The last page of this packet is an IYC 2012/Impact Denver Release/Waiver of Liability form. During IYC, we will be spending one afternoon serving the Denver area. We could do anything from cleaning a park or school to singing at a nursing home. This form needs to be completed and returned by **January 11th**. **This form is required by the convention.**

The undersigned participant ("Participant") in IYC/IMPACT Denver, sponsored by Church of God Ministries, Inc., in Denver on July 4-7, 2012 and Participant's parent(s) or legal guardian(s) (if Participant is under 18), in consideration of the benefits received from Participant's participation in IYC/IMPACT Denver, individually affirm and agree for July 4 through July 7, 2012 that:

1. **Acknowledgment of Risk.** I fully understand and acknowledge that participating in IYC/IMPACT Denver activities may entail hazards, dangers, and other risks to bodily health, safety, and well being. Such activities, risks, hazards, and dangers may include, but are not limited to, the following: inflatable game activities, dehydration, general transportation issues, hotel safety, city threats, exposure to illness, theft/loss of personal belongings, loud music, exposure with homeless individuals, protesters, and crowded areas, etc. I understand that the risks and dangers inherent in these activities may be caused by the negligence of Participant in the activity, the negligence of others, accidents, breaches of contract, forces of nature, human hostilities, or other causes, and knowingly accept those risks.
2. **Obligations of the Participant.** As a condition of participating in IYC/IMPACT Denver, Participant shall (1) learn and consistently follow the rules governing IYC/IMPACT Denver and its associated activities, (2) obey all instructions of IYC/IMPACT Denver staff and volunteers, and (3) alert IYC/IMPACT Denver staff immediately of any dangers or hazards to the safety of any individual(s) in IYC/IMPACT Denver that Participant perceives.
3. **Permission.** I give permission for Participant to participate in IYC/IMPACT Denver and all of its associated activities, including but not limited to those described in Section 1, above. I also authorize IYC/IMPACT Denver and Church of God Ministries, Inc. its agents, and any agencies it works in conjunction with to provide medical treatment to Participant, as specified below in Section 5, below, "Medical Authorization."
4. **Liability Waiver/Release.** In consideration of Participant's participation in IYC/IMPACT Denver, and intending to be legally bound, I hereby, for myself, my heirs, executors, and administrators, assume all risks and dangers identified above and hereby agree to release and hold harmless IYC/IMPACT Denver and Church of God Ministries, Inc., its service providers, employees, volunteers, directors, officers, other agents, and any agencies it works in conjunction with from any and all liabilities, claims, demands, actions, or losses for or from bodily injury, property damage, sickness, wrongful death, loss of services, or otherwise, which may arise out of Participant's participation in IYC/IMPACT Denver or related activities and which may arise out of Participant's participating in any activity associated with IYC/IMPACT Denver.
5. **Medical Authorization and Release.** I understand that Church of God Ministries, Inc., will make every effort to contact Participant's parent(s) and/or guardian(s) (if Participant is under 18 years of age) in the event of a medical emergency. Nevertheless, I hereby give permission and authorize IYC/IMPACT Denver and Church of God Ministries, Inc. and its agents, at any time they believe an emergency exists, to provide, facilitate, and consent to the provision of any first aid, doctor's care, hospitalization, surgery, transportation to medical facility, and/or any other form of medical care or treatment that IYC/IMPACT Denver and Church of God Ministries, Inc., determines that Participant may need because of illness, injury, or other health problems that Participant may suffer while participating in IYC/IMPACT Denver or its associated activities. I agree to be financially responsible for any medical bills incurred as a result of medical treatment

for Participant. I agree to release and hold harmless IYC/IMPACT Denver and Church of God Ministries, Inc., and its employees, volunteers, directors, officers, other agents, and any agencies it works in conjunction with, from any claims, liabilities, actions, demands, or losses for or from bodily injury, property damage, wrongful death, or otherwise, which may arise from provision or omission of any type of medical care or transportation to or from a treatment facility by those chosen by IYC/IMPACT Denver and Church of God Ministries, Inc., to administer medical care for and/or transport Participant, and which may arise by any cause, including through the negligence or carelessness of IYC/IMPACT Denver and Church of God Ministries, Inc., its agents, or any agencies it works in conjunction with. I understand that all reasonable safety precautions will be taken at all times by Church of God Ministries, Inc., and its representatives during the events and activities.

6. Authorization to use picture, name, voice, and likeness. I grant to IYC/IMPACT Denver and Church of God Ministries, Inc., and to its successors, licensees, and assigns, the irrevocable right (but not obligation) to use Participant's name, likeness, voice, photograph, and/or video image in program materials, promotional materials, highlight video, and other works, including but not limited to news releases, publications, film or video programs, radio or TV announcements, Internet display, and for any other use by IYC/IMPACT Denver and Church of God Ministries, Inc., in its sole discretion.
7. Indemnity. I agree to accept sole responsibility and liability for any injury or damage to a third party resulting from my acts or omissions and I agree to hold IYC/IMPACT Denver and Church of God Ministries, Inc. its volunteers, employees, officials, directors and agents harmless from any lawsuit or claim arising therefore, and I agree to indemnify IYC/IMPACT Denver and Church of God Ministries, Inc., its volunteers, employees, officials, directors, agents, and any agencies it works in conjunction with, in the full amount of any judgment or settlement obtained and/or any expense incurred (including attorney fees) as a result of my actions.
8. Severability. If any term or provision of this Agreement is found to be unenforceable, the remaining terms and provisions shall remain in full force and effect.
